II. Minister Report: Rev. Drew Johnston

- A. Themes—The theme for this church year has been honesty. Proposed theme for next church year is leadership development. There needs to be accountability and responsibility. A new kind of leadership needs to be nurtured because there is a disconnect because ideas are proposed but little initiative to follow through. "Project Management" is needed. One model of leadership needs to be decided on and utilized.
- B. Canvass—Current model of the rolling canvass is not flourishing. Reevaluation is needed and perhaps reorganizing. Part of the problem may be due to lack of publicity and communication with canvassers. Rev. Drew with talk with canvass leaders.

A. Portfolio Round Table

<u>1. Worship—Alicia</u>: Committee has not decide how they might use the welcoming trustee for the summer services.

- <u>2. Membership—Alma</u>: (1) Since Drew has been here 35 people have signed the Membership Book with 28 being active. There are 10—15 people interested in signing or resigning. (2) All are invited to the SOUL concert on Friday, June 5 at 7:00. \$10
- 3. Building & Grounds—Bill: (1) Thanks to Linda D. for finding someone to repair roof leak over one of the rooms Sugar Law is renting. (2) Some plastering done, also. (3) Using Job Corp to prepare 2nd floor area for Sugar Law worked out. (4) Can carpet squares like those used on 2nd floor be used for McCollester Hall? Needs discussion. (5) Cooling for 2nd floor. Drew: cost estimate for central air--\$15,000 but may be able to be done for \$10,000. Other option is individual window air conditioners. Bill will check window air conditioner prices and specifications at Home Depot and Lowe's. Alma will check same at Costco.
- 4. Life Span Leaning Task Force/Publicity—Dessa: (1) Task force has met and has written a charter. In attendance were: Rev. Athena Kolbe, Dessa, Sharlene, Rev. Drew. Purpose is to develop educational activities for Church and community and enhance the Sunday experience. Volunteer childcare isn't working. There will be 2 paid staff for this managed by Rev. Athena. A committee of 4-5 will be established with assistance from the Nominating Committee with Rev. Kolbe as ex-officio member. (2) Community Service will not be part of Life Span Learning. Membership Committee will be asked to consider including this in their tasks. (3) Pride Day will be Sunday, June 7 in Ferndale. Farmington UU Church has made contact with us to share a table for literature and to publicize that we are a welcoming community. Table would cost \$150, but cost would be shared. Waiting for confirmation from Farmington people.
- <u>5. Social Media/AVIT/Communications</u>—Dave: He and Dessa met with AVIT group. They are having difficulty with writing their charter to become a committee.
- <u>6. Finance—Sharlene</u>. Organ Concert profits.

MOTION: Sharlene moved that the donation from Thelma Murriel for \$1000 and \$400 from ticket and CD (as of 5/13) be kept in a Temporarily Restricted Fund for organ upkeep. Seconded by Alicia. **PASSED**

- 1. Fundraising policy. Policy was passed on April 8, 2009 with some changes in language. Final wording: In order to maintain a healthy church, it is the policy of the Board of Trustees to support friend-raising and fundraising events to generate additional revenue to fund the church. All events must be approved by the board, follow all IRS guidelines for fundraising and honor the mission of the church. Finally, all donations made to an event are for the event only and will not be counted toward a member's pledge. Instead, the appropriate amount will be credited for tax reporting purposes.
