A. Meeting with the Search Committee until 8:20. Discussion of issues and concerns from the Board and Committee. Committee will proceed with next 2 phone interviews and then evaluate whether they will continue.

### II. Minister's Report: Rev. Drew Johnston

- A. Printed Reports—Profit & Loss, Jan. 1 through Feb. 9, 2010; Profit & Loss, Jan. 2010. (Attached)
- B. Final mortgage payment has been made.
- C. Books are closed for 2009, but still some payments needed for dues, minister's pension and retirement. Corrected pension payments need to be made still for 2007, 2008. Further payments need to be made to Nina, accountant.
- D. We will be \$10,000 to \$12,000 short a month to meet budget expenses without Trust money.
- E. Monthly reports from OuickBooks can be shown as graphics in the future.
- F. Last deposit from Trust doesn't show up in P & L. (Undeposited funds don't show up as income.)

- G. Any expenses to cut? Ideas: "Mothball" parts of buildings we don't really need to use. (2) Rent out more space. (3) Review vendor use and their bills.
- H. Definition of "year" for listing trust income—Should it be calendar or fiscal year?(Not decided.)
- I. Sunday morning counting of offering with Jenn. Needs trustee to assist. Marilyn gets money and takes it to office to help with count. Sally will be back up person for this.
- J. Before PowerChurch is closed out 2 six-month financial reports will be generated.
- K. Canvass—Janet Thompson, Chair has been working with Glenn and Drew. Update and training will be Wed. Feb. 17 at 7:00 PM
- L. Rental Space Matters
  - 1. Unity. Will pay \$200 less a month, but lease on a month to month basis.
  - 2. Sugar Law rental space issue due to persistent water leak. Needs a permanent space rather than just reduced rent as is being done now. Possibility of using Minister's office on 2<sup>nd</sup> floor and room off chancel (now Cotman rental) could become Minister's Office.
  - 3. Company that repaired port cochere may be asked to see what they might be able to do to repair roof leak.
  - 4. Negotiations by Rev. Drew continue for renting large amount of building spaces with various groups that could bring in thousands per month.

- E. Nominations for Endowment Fund Committee. 3 members needed as new by-law stipulates. One member needs to have been on the Trust so Bill will be Chair and convener for a 3 year term. Alma will be recording secretary for a 2 year term. Still need to think of a 3<sup>rd</sup> member for a one year term as financial secretary.
- F. Discussion about nominating committee. Too many members on the committee are not active in other church activities. There is a need to develop a mentoring system for younger/newer members. Advisory committee as a link to the past to support younger/newer members as they fill board and other church leadership roles is a concept to develop.
- G. Rev. Drew's sermon on Feb. 28 will include talk about tasks around church members can do to be more active.
