Building Management

- The quotes from the furnace companies were presented and discussed. There were quotes from simple repair of our furnace to complete replacement, one including the outside air conditioning condenser. Most quotes included energy saving improvements.

- There was also a strategic quote combining the two systems for the McAdow House into one. This would simplify operation; include energy saving improvements; and enable further energy saving opportunities in the future. (10)
- Motion to implement the combined system; obtain alternative bids; and approve up to \$19,000 made by David Lingholm. This will both improve the long term viability of the McAdow House if we stay and make it more marketable if we sell. Passed.
