## UU Ministers Speak in Support of Labor

Note: The following two letters were recently drafted by Cassandra Howe, Consulting Minister in Portage, MI with input and agreement from several other Unitarian Universalist Ministers, in support of labor and worker's rights. The first has been sent to state legislatures in several Heartland states, while the second has been sent to labor organizations. Endorsed by the ministers listed at the bottom, these letters add more voices to the chorus of support for workers and their families.

Dear State Legislator:

As ministers in the Heartland District of the Unitarian Universalist Association, we are watching closely the unfolding debate that has spread across the middle of this country concerning workers' rights and the right to bargain collectively. We urge you to stand for justice and the rights of workers and lead other state leaders in a genuine conversation that will address the demands of the protestors.

As religious leaders, we believe in the inherent worth and dignity of every person and in justice, equity and compassion in human relations. Economic justice is a basic way we as a nation show human worth, and right now we need to know that our political leaders believe that every person -- no matter how rich or poor -- has the right to be heard and taken seriously.

What is happening in Wisconsin, Ohio, Indiana, and elsewhere is no longer simply addressing an issue about balancing the states' budgets; it is about certain state leaders manipulating a grave national concern -- a budget deficit -- for their own political benefit. In Ohio, the sponsor of the anti-union Senate Bill Five, Senator Shannon Jones, was asked how much money this legislation would save the state. She did not know. When asked why, then, was it being introduced, she said, "It's my philosophy. We do not believe that public employees should have the rights that they have now."

We are in trying times in the Midwest. In the midst of limited resources, we are forced to decide what to hold onto and what can be discarded. The right to collective bargaining derives from the rights of assembly and free speech -- rights fundamental to the building of our nation. Please show us that you stand for the preservation of these human rights and lead us in a more genuine, open conversation.
