Upcoming Sermon Schedule

August 7th — "Race, Class and Justice in America" Abayomi Azikiwe

Racial and class divisions are growing inside the United States despite the rhetoric of eight years ago that the country was becoming a post-racial society. Both the Republicans and Democrats have fostered these divisions through partisan rhetoric as well as the legacy of mass incarceration and financial deregulation. I will outline my thoughts on these issues and make some suggestions for actions to be taken on a community level.

August 14th — "Ecumenism, Yesterday and Today"

Reverend Stephen Butler Murray It is interesting that today, as individuals tend more toward quiet ecumenism rather than strict denominationalism, that the ecumenical movement itself is going through a considerable downsizing. In this sermon, I will talk about the history of how denominations decided to work together ecumenically through organizations such as the National Council of Churches, and how that intentional interdenominational organization and activism has unraveled. In addition, I will speak about atheist views about participation in ecumenical and inter-religious dialogue.

August 21st — "The Gospel of Bruce" Joel Batterman

The rise of Donald Trump has focused attention on America's white working classes: their fears, pains and aspirations. For nearly half a century, however, few public figures have given those feelings more eloquent voice than Bruce Springsteen, the Jersey-born poet-rocker who gained international fame in the twilight of postwar U.S. prosperity. What lessons does Springsteen's deeply humane vision hold for us today, as we stare down the twin threats of homegrown fascism and an intolerable status quo?

August 28th — "Detroit Musings, 'Scrap Metal Mantra': a Love Song to Detroit"

Ken Meisel

Ken Meisel is a poet and psychologist from Detroit, a Kresge Arts fellow and Pushcart nominee. He will read from his poetry, which has been called a "poetic homage" to the working class, "tinged with mortality and transience, giving it an anguished intensity."

Letter from the President ...

Greetings to the UU Detroit community!

Last month I had the honor of attending 2016 General Assembly in Columbus, OH with UU Detroiters Joel Batterman, Linda Darga, Robert Johnson, Carolyn Ludwig, Mary Lou Malone, Glenn Maxwell, Sharon Mills, Marilyn Mitchell, Danny Rebb, and Jennifer Teed.

As your elected delegates, Robert, Danny and I participated in a contentious vote at GA: whether to choose to study race or the corruption of American democracy for the next congregational study/action issue, which will be taken up by congregations from 2016 to 2020.

I voted to study the corruption of our democracy rather than to begin a national conversation on race. My vote was driven by my belief that we can't wait any longer to begin a national conversation on race and we certainly can't wait until 2020 to reach a national UU consensus. Conversation must begin now, action is needed. My vote was also influenced by my belief that racial justice work cannot be advanced if our leaders are undemocratic, or even corrupt.

Because I had to be back in Detroit, I missed the final session on Sunday. When I returned home and watched the video of the proceedings, I felt I had misplaced my vote. Fortunately, GA youth caucus leaders — supported by Black Lives of Unitarian Universalism — drafted a responsive resolution demanding a multiyear report on antiracism work from the Unitarian Universalist Association. The resolution passed unanimously, after the "reinforced Roberts Rules, rules-driven, we mean well" procedural system was abandoned and the youth and BLUU were invited to the stage for conversation. And they spoke.

I heard youth caucus leaders talk about their sense of betrayal because my vote meant I chose to fight a corrupt democracy but used a corrupt democratic process to do it; that not voting for conversation on race was a missed chance to make a public statement of support; that I voted to fight the system but I am the system — that the youth should not have had to write the resolution. The question posed was: what are you going to do, not what are you going to say?

I can't change my vote but I've been educated and informed for future action. I welcome your thoughts; catch up with me any time to talk.

After returning from GA, **Marsha Bruhn**, Glenn Maxwell, Joel Batterman, Linda Darga and I attended the <u>Viola Liuzzo Park dedication</u> on July 12, representing UU Detroit. Very shortly into his opening remarks, Viola's grandson, Joshua Liuzzo, affirmed that Viola was a "dedicated member of the Unitarian church." Viola is part of our legacy; she died fighting for civil rights. As we wake up each day horrified to hear of more and more murdered Blacks, I hope that we can live up to this legacy.

As UUs and as a congregation we come together to inspire, console, and hold up one another. Thank you for continuing to do so in these turbulent times. I am keeping our second principle, justice, equity and compassion in human relations, close to my heart and mind.

Quarterly Finances ...

Quarterly Report from the Finance Committee

The Church fiscal year which ended June 30, 2016 was unusual for our congregation in that we ended the year with a large surplus of revenue over expenses. Our revenues were just a little lower than the previous year as donations were about \$5,000 less but this was mostly offset by higher parking lot income which brought in \$15,600 this year compared to only \$11,750 the year before.

The main reason for the improved financial position was the reduction in expenses from the prior year. Total expenses for the year just ended were only \$80,287 which is down from the \$112,557 from the year before including payoffs or prior period liabilities. The big savings came from lower payroll costs due to the current contract for a part-time minister and elimination of employee positions.

This year's expenditures include having paid down another \$11,688 from old liabilities. We will complete paying off all old liabilities within the next few months pending calculation and agreement on the final payoff numbers.

While we did well financially we must keep in mind that a settled minister, even a part-time settled minister, is going to push expenses back up in the future. We also need to keep in mind that because our income is donor based, we cannot ensure the amount of future income. So while we did well we must be prudent in our spending commitments for the future. — **Bob Lauer, Treasurer**

THE MINISTERIAL SEARCH SURVEY IS COMING IN SEPTEMBER

A key part of the search process for a new minister to join us in September 2017 is a survey of our congregation: what do you think about ministers and church in general? Your Settled Minister Search Committee needs to know your views on these important matters. We need to know whether a significant majority feels a certain way on various questions. Or whether only a few hold a particular opinion.

The **survey will be emailed in early September** to friends and members who normally receive newsletters digitally. It will take about 15 minutes to answer, using Google Form survey software. If there are two members/friends sharing one digital newsletter, we ask that each complete the survey separately. Members without personal email access will be able to complete the survey on computers available during the social hour, on Sundays: September. And **surveys will also be available in a paper mail-in format**.

If you have questions about your confidentially, your survey answers will be anonymous. We won't know who is completing any individual survey.

The theme of this year's General Assembly was "Heartland - Where Faiths Connect."

Robert, Danny, and Kathe attended as your elected delegates. Individually or together, they participated in General Sessions, at which the business of the assembly is conducted, as well as Mini-Assemblies, small sessions for delegates to speak on issues.

Forum; gravely contested <u>Congregational Study Issues</u>; and a preview of a documentary based on UUs Martha and Waitstill Sharp, <u>Two Who Dared: The Sharp's War</u>, with an introduction by codirector Ken Burns. Artemis Joukowsky, the Sharps' grandson, who is also a co-director on the movie, was present.

Congregational Study/Action Issues (CSAIs) are issues proposed by congregations for four years of study, reflection and action. The CSAIs presented for vote were: #1 Climate Change and Environmental Justice; #2 A National Conversation On Race; #3 Ending Gun Violence In America; and #4 The Corruption Of Our Democracy.

CSAI #1 (climate) was withdrawn by the presenter, who deferred to CSAI #2 (race). The presenter stated that he believed current conditions in the United States more warranted consideration on race rather than climate. When the vote was taken, the results were evenly split between CSAI ## 2 and 4 (democracy). A second vote was taken, with the result that <u>CSAI #4</u> was selected by what was, again, a very close vote.

A CSAI is not a statement—it is a question. UU congregations are encouraged to study the issue presented in 2016 GA CSAI #4: "As corporations use 'corporate personhood' and 'money as speech' for their interests rather than the people's needs, can a constitutional amendment be passed to protect us? Could this further Unitarian Universalist work for social and environmental justice and help protect the health and safety of the people and the planet?"

UU Detroit at 2016 General Assembly ... cont'd

A lot of strong feelings continued to surface at GA 2016 after CSAI #2, a national conversation on race, lost to CSAI #4, a study issue on corruption of democracy. A responsive resolution demanding a multivear report on antiracism work from the UUA, drafted

by youth caucus leaders and supported by Black Lives of UU, was passed unanimously at the closing session.

We participated in the debate and vote on a bylaw amendment to suspend the AIW process at GA in 2017 in New Orleans; and on business resolutions: Reconsidering Thanksgiving (which passed) and Divestment from Corporations Complicit in the Violation of Palestinian Rights (pp 98 and 99) (which lost). The divestment issue raised strong feelings and debate.

Three <u>Actions of Immediate Witness</u> were debated and voted on at the GA closing session. The three were *Build Solidarity*



With Our Muslim Neighbors, Some Guns, All Guns: Legislating Appropriate Restrictions, and Stop The Hate: Protect and Support our Transgender and Gender 3 Non-Conforming Family. The Muslim solidarity AIW grew out of the Resolution of Muslim Solidarity approved at the MidAmerica Regional Assembly in March; UU Detroit was a signer of that resolution. AIWs are initiated by delegates and move through their entire creation and adoption process during one GA, expressing the conscience and carrying the authority only of the delegates at the GA at which they are passed.

At his very first GA Danny exercised his procedural rights by speaking at the "Pro" microphone in favor of the Muslim solidarity resolution, both as a member of First Unitarian-Universalist Church of Detroit and as a resident of Dearborn, home of the largest Middle Eastern population in the U.S. Danny also spoke at the "Procedures" microphone, moving to call the question on adding an amendment to the Stop The Hate: Protect and Support our Transgender and Gender 3 Non-Conforming Family AIW. His first motion made at GA was seconded and it carried!

GA 2016 was protested by members of the Westboro Baptist Church. An <u>impromptu peaceful demonstration</u> was organized against the protest; the WBC, carrying signs with hate messages, was met by <u>10 angels</u> and 200+ singing and chanting UUs. The "angels" had been used to block the WBC protest at the funerals of the Orlando shooting victims; they were designed by a member of the Unitarian Church in Orlando. Singing peaceful songs and chanting "love not hate," UUs in Columbus stood on the side of love. As the president of the Unitarian Universalist Association, Rev. Peter Morales, said: "You don't combat hate with hate. We just try to gently let our position be known and really try to counter hate with love."

The UUA invites a distinguished guest each year to address the General Assembly as the Ware Lecturer. The 2016 Ware Lecture featured broadcaster Krista Tippett of "On Being." The lecture and transcript are available on the <u>GA website</u>.

Worship services ranged from those which filled the huge convention hall to low-key, early-morning meditations. Meditation rooms were available for down time including a healing room set up for Blacks, only, to use, in keeping with the UUA's escalating commitment to the Black Lives of UU movement. Some of the convention center's bathrooms were transformed and dedicated as gender-neutral. There were many recycling stations spread throughout the convention center.



Workshops were as diverse as the UUs who attended them. The "Black Lives of UU" track that many of us followed was quite a refreshing change from General Assemblies of the recent past, which generated some ugly, privileged behavior. Materials and, in some cases, videos from workshops will be available on the <u>UUA website</u> and you may read thorough coverage of GA 2016 in the <u>UU</u> <u>World</u>.

Kathe and Sharon participated in a Ministerial Search Committee Orientation organized by the UUA Transitions Office. Transitions Director Keith Kron explained what constitutes a successful search and talked about the most common mistakes search committees make in the search process, followed by a Q&A period. The orientation provided valuable information and insight into UU Detroit's process as we search for a settled minister.
